

**ARG-2945, Rev. 06/06**

**Part II**

**“Additional General Terms and Conditions Applicable to Orders Issued Under Government Contracts”**

- (a) In the event that pursuant to a prime contract with the US Government or a subcontract which was let under a US Government prime contract, the Buyer is flowing down Federal Acquisition Regulation (FAR) and Defense FAR Supplement provisions and clauses (DFARS) (all herein “FAR Clauses”) to Buyer’s subcontractors, those FAR Clauses current as of the date of the prime contract that are flowed down are incorporated herein by reference, in the manner provided below. Seller shall include in each lower-tier subcontract the appropriate flow-down clauses as required by FAR and DFARS.
- (b) In interpreting and applying FAR Clauses flowed down to the Seller, and as the context requires, the terms “Contractor” and “Offeror” shall mean Seller, the term “Contract” shall mean the Buyer’s purchase order, and the term “Government”, “Contracting Officer” and equivalent phrases shall mean Buyer and/or Buyer’s purchasing representative. However, as an exception to the foregoing, the terms “Government” and “Contracting Officer” do not change in the following circumstances:
- i. in the phrases “Government Property,” “Government-Furnished Property,” and “Government-Owned Property;”
  - ii. in the Patent Rights clauses incorporated therein, if any;
  - iii. when a right, act, authorization or obligation can be granted or performed only by the Government or a Contracting Officer or his/her duly-authorized representative;
  - iv. when title to property is to be transferred directly to the Government;
  - v. when access to proprietary financial information or other proprietary data is required, except as otherwise provided in the purchase order; and
  - vi. where specifically modified in the purchase order and provided, further, that all references to the clause entitled “Disputes” or Contract Disputes Act shall be deemed deleted.
- (c) FAR Clauses flowed down by Buyer to Seller pursuant to this provision may require submission of certificates. U.S. Government required representations and certifications made by Seller in connection with flow down of FAR Clauses, including all such certifications submitted by Seller with its offer, are incorporated in the Buyer’s purchase order by reference. Seller shall, with respect to FAR Clauses flowed down pursuant to this provision, furnish to Buyer (or directly to the Government upon request of Buyer) any certificate required to be furnished by any FAR Clause and any certificate required by any further US law, ordinance, or regulation with respect to Seller’s compliance with the terms and provisions of U.S. laws, ordinances, or regulations. As used in this paragraph, the word “certificate” shall include any plan or course of action or record keeping function, as, for example, a small business subcontracting plan for which flow down is required.
- (d) Seller shall indemnify and hold Buyer harmless from and against any price reduction in Buyer’s contracts with the U.S. Government, as well as Buyer’s reasonable attorney fees and other direct costs to defend U.S. Government claims when said reduction is attributable to the failure of Seller or Seller’s subcontractors to properly discharge applicable duties under the Truth in Negotiation Act and Cost Accounting Standards clauses incorporated by reference in accordance with this provision.

Additional clauses to these below are applicable if specified on the Order.

## **FAR Clauses**
